#### CONTINUATION ORDER

WHEREAS, recognition was granted to the institution viz. Devbhumi Institute of Professional Education, C/O Jaycees Public School, Rudrapur, District-U.S. Nagar, State-Uttarakhand for conducting B.Ed programme of one year duration with annual intake of 100 students vide Order No. NRC/NCTE/F-3/UR-52/4846-4855 dated 01.07.2005.


- 2. AND WHEREAS, the revised recognition was granted to the institution for conducting B.Ed. programme of two years duration with an annual intake of 100 students for two basic units of 50 students each from the academic session 2015-2016 vide order No. NRC/NCTE/UR-52/2015/105014-19 dated 26.05.2015 with the condition of adherence of provisions of NCTE Regulations, 2014. The institution has not submitted compliance of Revised Recognition Order.
- 3. AND WHEREAS, the matter was placed before NRC in its 406<sup>th</sup> (Part-1) (Online Mode) Meeting held on 01<sup>st</sup> to 3<sup>rd</sup> August, 2023 and the Committee decided to issued First Show Cause Notice Under Section 17 of NCTE Act, 1993. Accordingly, First Show Cause Notice was issued to the institution dated 23.08.2023. The institution has submitted reply letter dated 17.08.2023 & 08.11.2023 received in NRC office 26.08.2023 & 12.12.2023.
- 4. AND WHEREAS, the matter was placed before NRC in its 418<sup>th</sup> Meeting held on held on 23<sup>rd</sup> and 24<sup>th</sup> January, 2024 and the Committee observed and decided the following:-

The reply submitted by the institution vide letter dated 08.11.2023 with reference to the first show cause notice dated 23.08.2023, the Committee observed that the institution submitted documents as per provision of the NCTE Regulations, 2014 and found the same satisfactory.

Hence the Committee decided that the status quo of the institution be maintained and recognition granted to B.Ed. (two units) is hereby continued.

5. NOW THEREFORE, in the light of above the Northern Regional Committee, NCTE hereby allowed the institution viz Devbhumi Institute of Professional Education, C/O Jaycees Public School, Rudrapur, District-U.S. Nagar, State-Uttarakhand for continuing of B.Ed. programme of two-years duration with two basic units of 50 students each annually.

- 6. Further the recognition is subject of fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC. Affiliation University/Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Performance-Appraisal report (PAR) at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain its own website with hyperlink to the NCTE website uploading the required information/ documents as per clause 7(14) of the NCTE Regulation 2014 as amended time to time
- 9. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to date information on us official website.
- 10. If the Institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations, and orders made of issued there under, the action including withdrawal of recognition shall be taken by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
